

This has reference to your RTI application dated 11.2.13 received by us on 13.2.13 seeking information under RTI Act, 2005.

Our point-wise reply to query is as under:

Q.a Please provide information regarding funds earmarked and spend for oil conservation program which is observed by all three OMCs every year under the banner PCRA.
 Reply For the period 1.4.2009 – 31.12.2012, Oil Conservation Programme under the banner of PCRA was carried out in Jan 2010, Jan 2011 & Jan 2012. Funds earmarked by Indian Oil Corporation for Maharashtra & Goa are as under :

For 2010 – Rs. 12 lacs

For 2011 – Rs. 12 lacs

For 2012 – Rs. 15 lacs

Spending was done in line with the funds earmarked as above.

Q.b Please provide information regarding the name of the committee who has been allotting funds for observing oil conservation program .

Reply IndianOil, Head Office is allotting the funds for oil conservation.

Q.c Please provide facts and figures of sale drop (oil conserved) during the period of oil conservation program for the last three years.

Reply The Oil & Gas Conservation Fortnight (OGCF) focuses on organizing awareness programmes in 4 sectors, namely, Industry, Transport, Agriculture & Domestic. The performance of OGCF was assessed in 2011 by way of survey across Western Region comprising Maharashtra, Goa, Madhya Pradesh, Chhatisgarh & Gujarat. The survey was conducted before OGCF 2011 & after OGCF 2011 and it was found that the awareness levels increased from 23 % in pre-OGCF to 43 % in post OGCF.

Q.d Please provide information regarding annual budgetary allocation of funds by all three OMCs for sales promo campaign.

Reply We are giving below the amount of budget allocated to Retail Lube Department for period requested in RTI application.


2009-10 - Rs.110 lacs
2010-11 - Rs.160 lacs
2011-12 - Rs.174 lacs
2012-13 - Rs.240 lacs.
