(b)	Traditionally budgetary provisions are being made at the beginning of financial year for Oil Conservation programme, since it is annual ongoing programme of MOP & NG.
(c)	Oil Conservation programmes are basically organized to inculcate and develop the habit among General Public towards the conservation of oil & energy resources. Thus such programmes are purely for conservation and better use of fuels and are not aimed to reduce sales.
(d)	The information about annual budgetary allocation of funds for Sales Promotion requested by you, is confidential in nature and the disclosure of which has no relationship to any public activity, hence denied under section 8(1) (d) of the Right to Information Act 2005.
